It has come to the Court’s attention that a large number of the attorneys of record in this multidistrict litigation are not currently registered for an account on the Eastern District of Kentucky Electronic Filing System. Pursuant to this Court’s August 30, 2011 Order Regarding Practice and Procedure, every attorney with a case in this multidistrict litigation is required to register for electronic filing. The Order provides:

All attorneys must be registered with this Court’s Case Management/Electronic Case Filing (CM/ECF) system no later than **20 days** from the date of entry of this Order, absent application to the Court for relief from this requirement, and all filings in these actions must be made electronically via the CM/ECF system.
