

## Audit Assist

With the Audit Assist function, you can check for any error or warning messages that could impede processing of the voucher.

There are different errors and/or warnings that display a message when something is incorrect on a document. When you click **Audit Assist** on the voucher, if something is incorrect, you receive either an error or warning message. When an error message displays, you cannot continue with the voucher until the condition is changed. When a warning message displays, you can continue with the voucher, but your court may require more information or additional changes before the document is approved.


